## Getting Started - DCS Functionalities for Proper Analysis:

- Familiarization with HMI functions and operations.
- Review of DCS tools.
- Study of control loop structures: cascade, split-range on the simulator.
- Introduction to programmable logic controllers and automated sequences.
- Monitoring start-up sequence compressor through MMI.
- Description of Safety Instrumented Systems SIS: PSS, ESD, HIPPS, and F&G systems.

#### Unit 2:

#### Wells & Production Lines Operation:

- Well start-up ramp-up and shutdown.
- Analysis of automatic gas control.
- Monitoring and detection of abnormal conditions in wells.
- Operation of rotating machinery: centrifugal pumps and compressors.
- Review of technology, process lines, protection systems, and operating parameters.

#### Unit 3:

#### Process Upset Management:

- Management of alarms: priorities and decision making.
- Anticipation vs. on-alarm action.
- Utilization of trend views to predict process disturbances.
- Implementation of routine checks roadmap for global plant performance checks.
- Role-play situations for shift reports and structured reaction to process upsets.

#### Safety in Operation:



- Operating the plant in critical situations and making adequate decisions.
- Simulation exercises: handling gas leakage, inhibition, and downgraded situations.
- Manual ESD activation following leakage detection.

#### **Production Start-Up:**

- Analysis of production facilities start-up philosophy.
- Safe plant start-up procedures.
- Implementation of start-up procedure on the simulator.
- Anticipation of process upsets and handling malfunctions.
